MINUTES OF THE RENAL PATHOLOGY CLUB STEERING COMMITTEE MEETING

March 18, 1991

The committee meeting was held during the 80th Annual Meeting of the USCAP, in Chicago. In attendance were: Arthur Cohen, Vivette D'Agati, Robert Colvin, Gloria Gallo, Gary Hill, Vivian Pinn-Wiggins, Seymour Rosen, Melvin Schwartz; Charles Jennette, Secretary; Jay Bernstein, Chairman.

The first USCAP Companion Meeting offered by the Renal Pathology Club, held on March 17, was discussed. The companion meeting was titled CURRENT TOPICS IN RENAL PATHOLOGY, was moderated by Dr. Michael Kashgarian and Dr. Fred Silva, and included the following presentations: Anti-Neutrophil Cytoplasmic Autoantibodies by Charles Jennette, HIV and the Kidney by Arthur Cohen, Recent Advances in the Pathogenesis of Renal Allograft Rejection by Robert Colvin, and Renal Cell Carcinoma: Review and Update by Barbara Bane. The consensus opinion was that the companion meeting had been well attended, and well received.

The program for the next USCAP Companion Meeting in March of 1992 was decided upon. Dr. Bernstein will chair the session, which will include the following presentations: Renal Allograft Evaluation by Aspiration Biopsy by Cynthia Nast, Wilm's Tumor and Nephroblastomatosis by Bruce Beckwith, Hemolytic Uremic Syndrome by Vivette D'Agati, and Lupus Glomerulonephritis: The Results of the Lupus Collaborative Trial by Mel Schwartz.

The Renal Pathology Club program for the next NKF meeting in November of 1991 was also discussed. A symposium on Cyclosporine toxicity was agreed upon, with Vivette D'Agati as organizer. The symposium will include the following presentations: Morphologic Features of Cyclosporine Nephrotoxicity by Michael Mihatsch, Pathogenesis of Cyclosporine Nephrotoxicity by Giuseppe Remuzzi, and Clinical Update of Cyclosporine Nephrotoxicity by William Bennett.

A revised version of the bylaws for the Renal Pathology Society were considered. Several minor modifications were suggested. The suggestion was made by Dr. Bernstein that the proposed bylaws of the Renal Pathology Club be circulated to the members of the Renal Pathology Club after the November 1991 NKF Meeting, discussed with the membership at the March 1992 USCAP and November 1992 NKF meetings, and considered for ratification at the 1992 NKF meeting. Solicitation of opinions about the transition to the Renal Pathology Society only by mail was not judged to be adequate.

Dr. Bernstein appointed an ad hoc membership committee to formulate membership requirements and a membership application form for the Renal Pathology Society. Committee members are Charles Jennette (Chair), Mel Schwartz, and Arthur Cohen.

The following physicians were proposed and accepted for membership in the Renal Pathology Club: Guillermo A. Herrera, Maria M. Pickens, Daniel D. Sedmak, and Roger D. Smith. (Note: Dr. Smith was later found to already be a member.)

MINUTES OF THE RENAL PATHOLOGY CLUB BUSINESS MEETING

November 17, 1991

The Renal Pathology Club Business Meeting was held on November 17, 1991 during the Annual National Kidney Foundation Meeting in Baltimore, Maryland. The membership had been notified by mail that a decision about becoming the Renal Pathology Society would be made at this meeting. Twenty seven members, including the Chairman, Dr. Jay Bernstein, and Secretary, Dr. Charles Jennette, were in attendance.

Dr. Bernstein began the meeting with a historical overview of the Renal Pathology Club, which originated in 1978 with Dr. Conrad Pirani as Chairman. Dr. Bernstein also summarized the participation of the Renal Pathology Club in the Annual National Kidney Foundation/American Society of Nephrology Meeting and the Annual United States and Canadian Academy of Pathology Meeting. The possibility of the Renal Pathology Club becoming a Council of the National Kidney Foundation was considered, but this option did not have the support of the membership present.

Most of the meeting focused on the transition from the Renal Pathology Club to the Renal Pathology Society. The Renal Pathology Society Bylaws that were proposed by the Renal Pathology Club Steering Committee were considered in detail. A number of modifications were agreed upon. After completion of the discussion of the bylaws, Dr. Arthur Cohen moved that the Renal Pathology Society Bylaws be adopted with the recommended changes, and Dr. Fred Silva seconded the motion. Dr. Bernstein declared that the Renal Pathology Club was now the Renal Pathology Society.

Dr. Bernstein noted that, in accordance with the Bylaws, everyone on the Renal Pathology Club membership list was now automatically a Charter Member of the Renal Pathology Society; although, to maintain this membership, a modified (i.e., without the requirement for sponsorship) application form and dues must be submitted to the secretary within three months of receiving the application form.

Plans were made to hold the next Renal Pathology Society Scientific and Business Meetings during the March 1992 USCAP Meeting in Atlanta, Georgia. The Scientific Meeting will be the Renal Pathology Society Companion Meeting to be held at 8:30 a.m. on March 15. This will be followed immediately by the Business Meeting.

The Business Meeting was adjourned.
